5. How to Enter

Online: This method of entry will be available by visiting our website (bunnyears.com/CNC) and following the directions provided to fill out the entry information, and submit.

Limit one (1) entry per person, per email address, and per household for the duration of the Contest Period, regardless of method of entry. 6. Prize Drawing

7. Winner Notification

The potential winners will be notified by email, mail or phone.
